**4. Details of our assessment****RCTCBC Tip Leachate and Site Drainage AN0244804****Report**

This CAR form has been prepared as part of a data audit for the tip leachate and site drainage permit associated with the former Coed Ely colliery and coke works site (Permit AN0244804).

The audit reviewed discharge consent notifications and any pollution-related incidents, including associated CARs, covering the period from NRW's last site inspection on 15/04/2024 to 20/03/2026. No pollution incidents related to site drainage were identified, and no CAR actions were required.

Discharge notifications were reviewed for the following dates:

02/09/2024, 01/10/2024, 30/10/2024, 19/12/2024, 29/04/2025, 24/06/2025, 18/09/2025, 20/10/2025, 26/01/2026 and 23/02/2026.

No breaches of conditions were found in the discharge notifications. The notification for the 29/04/2025 discharge initially had a sample result of 2.26mg/l for ammoniacal nitrogen (N) which exceeded the maximum permitted concentration as specified in "8. COMPOSITION" of the permit. As the notification was submitted prior to the discharge, action was taken to ensure adequate dilution had occurred before a revised discharge date.

**Advisory Comments**

Continue to provide sampling results to NRW 1 week prior to the discharge as recommended in CAR\_NRW0044030.
