### 4. Details of our assessment

Compliance inspection of Cardiff Eastern District pumping station long sea outfall. This

inspection is linked to the sister permit of the SSO at Cardiff Eastern District AN0308601. There will be a separate CAR for that permit under CAR\_NRW0051173, however the information will remain the same.

This inspection was due to the annual maintenance of the asset which requires a HVAC to lift the large concrete covers. In the previous CAR NRW requested DCWW undertake this annual maintenance prior to the bathing season and to inform NRW to line up the maintenance with a visit so that the screens can be inspected.

The screens were cleaned on the day prior due to the work not taking as long as DCWW initially thought. Before and after pictures were taken of the screens for comparison. The site consists of two large screens which self clean with a mechanical flipper arm that sends the screened debris back into the main sewer headed for Cardiff works. These appear to have been working effectively due to the clean condition of the screens.



On the previous inspection in May 2025 there was only one EDM monitor for the LSO discharge, however there has now been an EDM monitor installed and operational for the SSO to record the spills separately. This is now displayed on the storm overflow map and also shown on the telemetry display on site.
