#### 4. Details of our assessment

Summary of Flow Pass Forward (FPF) (NRW FPF 2025 Submission) data as required by permit conditions linked to UMON3,4 driver submitted on 28<sup>th</sup> February 2025.

The result for FPF > 92% was 29.03%

As the FPF percentage above 92% of FFT was less than 95%, this is a breach of permit condition 3.1.2

This is a category 3 breach pending a review of guidance

Cause of breach and route to compliance provided by DCWW :

*New risk identified in 2024 as a potential non-compliance. Investigations were carried out early 2025 and identified pump performance as the primary cause. Replacement pumps have now been ordered but due to long lead times and supply issues with the suppliers we are still awaiting delivery. Expected in July and will be installed shortly after.*
