4. Details of our assessment

This Compliance Assessment Report is being produced following an inspection of Rhayader Depot, conducted by Luke Taylor (Senior Officer - Waste Regulation) of Natural Resources Wales.

The weather at the time of the inspection was cold, with light sleet. The site was operational and the officer was accompanied throughout by the site Technically Competent Manager, Nigel Hicks.

W1A General Management

The TCM qualification for Nigel Hicks is in date and covers the permitted activities at site. Mr Hicks is on site for more hours than is required to satisfy the permit condition, with details of staff site attendance being recorded.

The site management system is available to review in the site office as required. This was not reviewed in detail as part of this inspection.

W2A Permitted Activities

The waste transfer building was inspected, with waste quantities being fairly low and all wastes segregated within the correct bays. All doors to the transfer building were closed, as required by the odour management plan, the most recent copy of which is available to staff on site.

The upper yard area was inspected, with all wastes within storage limits and the defined bays. Food waste was within the sealed container, with the area being clean and free from and deposits.

W3B Emissions of substances not controlled by emission limits

During the inspection there was no odour noted on site, other than a slight odour within the transfer building itself when stood in front of the residual waste bay.

On the upper yard area, where the food and green waste streams are stored, there was no odour detected.

Outside the site, from the public car park located to the South West, there was no odour detected.

A record is being kept of daily odour checks, as required by the odour management plan, with any odours on or off site being recorded.

W4B Reporting - Permit Condition 4.2.2 - Category 4

Following the inspection, a review of the waste returns for the site was conducted, and it was noted that no returns have been received for Q3 or Q4 2025.

The above permit condition states that: 'Within one month of the end of each quarter, the operator shall submit to Natural Resources Wales using the form made available for the purpose, the information specified on the form relating to the site and the waste accepted and removed from it during the previous quarter.'

ACTION - Submit outstanding waste returns for Q3 and Q4 of 2025 to NRW. Deadline 30/04/2026
