4. Details of our assessment

This Car form also relates to CAR_NRW0048344 from March 2025.

The same issue referred to in the above Car form remains. In that, Cwm Sewage Pumping Station cannot consistently be achieved for 13.7 l/s.

A proposal to solve this problem has been developed, to be completed by the end of 2026.

Please provide detailed design plans of the proposed solution with a firm time frame for completion by 31 May 2026

NRW will contact DCWW data team for spill information relating to the 2025 bathing water season (May to September).

Email received from DCWW on 30 March 2026, which confirmed key programme milestones as follows:

- **Enabling works started on 23 February 2026**
- **Over-pumping trial scheduled for 29 April 2026**
- **Main construction phase planned from 18 June 2026 to 19 January 2027**

There is a slight delay owing to pump procurement.

Please continue to update NRW during the main construction phase.
