



On 18/03/2026 Natural Resources Wales Senior Environment Officer from the Cwm Taf and Bridgend Environment Team carried out a compliance inspection of water quality discharge permit references AN0308201, AN0308301, AN0385601, AN0011701 and AN0320901 for Gelli spoil tip / Nant y Gwyddon Landfill site. I was accompanied by Amgen Rhondda Cynon Taff County Borough Council Landfill Technician / Manager. The weather was dry and bright.

This report is for permit reference AN0011701 – Discharge to the Rhondda Fawr.

Discussions with the Technician confirmed that the leachate is currently being discharged to the foul sewer, with them not being aware of the discharge to the watercourse having ever been used. Leachate disposal is on a timed pump to discharge to the foul sewer (see image 1). The position of the installed leachate drainage means it also picks up groundwater, so the leachate is usually quite diluted.

We identified the discharge chamber at the location detailed on the permit. No discharge was visible from chamber at the river during the inspection (see image 2).

A small leak from the pipework for the leachate pump was noticed (see image 3). It appeared relatively minor with no odour or discoloration. NRW advise that the pipework is repaired.

If you are not satisfied with the outcome of the stage 1 review, you may request a **Stage 2 appeal**. This request must be submitted **within 21 working days** of receiving the response from the stage 1 review.
