## 4. Details of our assessment

On the 10 March 2026 a routine sample was collected by Natural Resources Wales from the sample point of the Sewage treatment plant serving Hidden Caravan park and revealed an exceedance in the following discharge parameter.

*Non-Compliances (recorded in summary) Actions to be addressed –*

Biological Oxygen demand (BOD)

Permit limit 20mg/l

Sample result 211 mg/l

This result represents a minor breach and has been assessed as a Category 3 environmental impact (Minor).

Please ensure the sewage treatment plant serving Hidden Caravan Park is brought back into regulatory compliance and provide any evidence of works carried out to action this to NRW by the 13 April 2026.
