## 4. Details of our assessment

NRW attended the site on 23/02/2026 to inspect the package treatment plant (PTP) serving the Red Kite Touring Park.

At the time of the visit there was no discharge; however, it was evident that if a discharge were occurring, it would be difficult to obtain a sample because the sampling point does not provide a suitable place to fill a sampling container.

Condition 3.3.1 states that permanent means of access must be provided to enable sampling and monitoring to be carried out in relation to the emission points specified in Schedule 3, Tables S3.1, S3.2 and S3.3, unless otherwise agreed in writing by Natural Resources Wales.

It is the responsibility of the permit holder to ensure that a sample can be safely and effectively taken at the sampling point to demonstrate that the effluent is compliant.

### **Action required:**

A V-notch must be installed at the sampling point to allow a sample to be taken. This action must be completed by **01/05/2026**, and confirmation should be provided by sending photographs to **timothy.arlett@cyfoethnaturiolcymru.gov.uk**.
