4. Details of our assessment

This report supercedes CAR NRW0051194, dated 27/03/2026 and all compliance assessment scoring within that report.

On Wednesday 1st April 2026, NRW (Natural Resources Wales) received a Material Facility withdrawal notification from the site. This withdrawal notification informed NRW that the site is not currently operating as a Materials Facility. Therefore, there is no requirement to submit additional material facility sampling waste returns or a copy of a written sampling methodology to NRW at this time.

Upon resumption of any Material Facility activity you must assess the amount of waste material that the facility is likely to receive during the relevant year as outlined in Schedule 9 of The Environmental Permitting (England and Wales) Regulations 2016 as amended by The Environmental Permitting (England and Wales) (Amendment) Regulations 2023. You may then subsequently be required to re-notify, undertake sampling and reporting to NRW as detailed in the regulations.
