4. Details of our assessment

On 12 March 2026, a routine sample was taken which exceeded the allowable limits for Suspended Solids (SS). As described within the emissions limits of Permit AB3199FF (Condition 3.1.2). Following analysis, the sample results contained the following:

Following this sample exceedances, Parkwood Outdoors are therefore in breach of the discharge permit condition 3.1.2, which is detailed below.

*****Breach of Permit Condition***

3.1.2: The limits given in schedule 3 shall not be exceeded.

This noncompliance has been assessed as a category 1 noncompliance, based on the level of the numerical failure.

Category 1 breaches of the permitted condition, which is considered a noncompliance with the potential to have a major impact or effect on the environment. The result was over double the limit stated within the permit. As such, our scoring categorisation guidance for numeric breaches states a category 1 noncompliance is appropriate (a private discharge result which is more than twice the absolute limit stated within the permit).

Action required:

You will need to investigate the reason for this failure and identify a suitable means of returning to compliance as soon as possible but not later than 30 April 2026. All findings should be shared with NRW by email to environmentteam.southpowys@naturalresourceswales.gov.uk
