Summary of Flow Pass Forward (FPF) (NRW FPF 2025 Submission) data as required by permit conditions linked to UMON3,4 driver submitted on 28th February 2025.

The result for FPF > 92% was 93%

As the FPF percentage above 92% of FFT was less than 95%, this is a breach of UMON3,4 permit conditions.

This is a category 3 breach pending a review of guidance

Cause of breach and route to compliance provided by DCWW :

Site trending towards compliance 2025. 2026 flow is still drifting in and out of compliance however the inlet flow control package to be delivered early 2026 to resolve and add resilience.
