#### 4. Details of our assessment

Summary of Flow Pass Forward (FPF) (NRW FPF 2025 Submission) data as required by permit conditions linked to UMON3,4 driver submitted on 28<sup>th</sup> February 2025.

The result for FPF > 92% was 32.07%

As the FPF percentage above 92% of FFT was less than 95%, this is a breach of permit condition 3.1.2

This is a category 3 breach pending a review of guidance

Cause of breach and route to compliance provided by DCWW:

*Grit in the SPS pumps and wet well restricting pump performance. Operations are looking to install flushing valved to clear the grit and maintain performance. Install to be completed by May 2026.*
