4. Details of our assessment

On the 18th of November 2026, NRW received a self report from DCWW regarding a foul pump issue on site which caused the Pumping Station to enter HIGH level. This resulted in the storm pumps briefly running, causing a discharge to the environment. The discharge lasted for approximately 2 hours.

DCWW investigated the issue and discovered that two fuses had gone in Foul Pump No.1. The site continued to control flows from Foul Pump No.2. Repairs were made and the issue has since been resolved.

The discharge caused by the pump failure resulted in the following permit breach:
