#### 4. Details of our assessment

Summary of Flow Pass Forward (FPF) (NRW FPF 2025 Submission) data as required by permit conditions linked to UMON3,4 driver submitted on 28<sup>th</sup> February 2025.

The result for FPF > 92% was 67.32%

As the FPF percentage above 92% of FFT was less than 95%, this is a breach of permit condition 3.1.2

This is a category 3 breach pending a review of guidance

Cause of breach and route to compliance provided by DCWW:

*New pumps installed in 2025, but insufficient spills to bring into compliance for the year. Site is trending Q95 compliant YTD.*
