## 4. Details of our assessment

Summary of Flow Pass Forward (FPF) (NRW FPF 2025 Submission) data as required by permit conditions linked to UMON3,4 driver submitted on 28<sup>th</sup> February 2025.

The result for FPF > 92% was 13.52%

As the FPF percentage above 92% of FFT was less than 95%, this is a breach of permit condition 3.1.5

This is a category 3 breach pending a review of guidance

Cause of breach and route to compliance provided by DCWW:

*New risk identified in 2024 as a potential non-compliance. Root cause investigation completed early in 2025 concluded that due to the only suitable location for U\_MON4 monitoring being downstream of site returns, this has resulted in return flows being pumped at too high of a rate to achieve FPF compliance. A solution for this is being developed to integrate speed control on the return pumps to allow us to implement efficient control and ensure returns operate in suitable conditions only. We expect this intervention to be completed in 2025 with a view to restore compliance in 2026. A weir raise is now needed following MON3 installation and is planned for April 2026.*
