4. Details of our assessment

Report:

On 13th March 2026 Natural Resources Wales(NRW) received a Self-reporting WATPOL from Dwr Cymru Welsh Water (DCWW) regarding a spill from Merthyr Tydfil Georgetown Lines Bridge CSO. DCWW have in place an Environmental Permitting Regulations (2016) permit (AN0250201) for this asset that allows a water discharge activity under strict conditions at SO 04213 06824.

There was light rain at the time of the incident but it had rained heavily for the previous few hours.

Breaches of permit condition:

DCWW technicians had received notification of the spill from their asset telemetry and once onsite proceeded to investigate, concluding that the root cause of the spill was a partial blockage in the downstream sewer network, caused by a build up of wet wipes. The blockage was cleared and the asset ceased spilling, this was evidenced by photographs and EDM telemetry data, confirming that the asset spilled for approx.. 30 minutes.

The spillage is a breach of permit condition 2.3.1 (a) (i) (ii)

For the discharge specified in table S3.3:

(a) The discharge shall only occur when and only for as long as either:

- (i) the flow passed forward is equal to or greater than the overflow setting indicated due to rainfall and/or snow melt or*
- (ii) the hydraulic capacity of the sewer network downstream of the combined sewer overflow is reached due to rainfall and/or snow melt and the level of storm sewage in the sewer at the combined sewer overflow is greater than the weir level of the overflow structure which is specified as an overflow setting in table S3.3.*

Photographic evidence provided show little to no visible impact to the river and water quality samples were not taken at the time due to Health and Safety access and egress concerns.

Due to the duration of the spill, photographic evidence and lack of water quality samples NRW categorise this as a CAT 3 breach of permit compliance: A non-compliance which could have a minor environmental effect.

The investigation and CCTV work carried out by DCWW on the day confirmed the cause of the incident alongside other issues that have the potential to cause the CSO to spill outside of permitted conditions, specifically root ingress to the sewer and a displaced sewer joint. These issues have been rectified and no further action is required.
