4. Details of our assessment

This Compliance Assessment Report (CAR) has been raised in relation to the Q1 2026 monitoring returns.

The Q1 monitoring returns were received on 7th April 2026 for discharges from W1 and W2 emission points in compliance with permit condition 4.2.3.

All reported parameters were in compliance with the emission limit values (ELV's) applied by permit condition 3.3.1, Schedule 3(b), Table S3.2 except for suspended solids.

The limit for suspended solids for emission point W1 is 50mg/l. The result was 52.4mg/l.

A Part A and B Schedule 5 was submitted on 28th January 2026 in compliance with permit condition 4.3.1.

Investigations into the breach revealed that solids were increasing across the biotowers and not being fully removed by the secondary Dissolved Air Flotation (DAF).

The site has already implemented the following actions in response to the breach;

- Trialling a cloth filter to remove solids
- Implementation of nutrient dosing to optimise the microbiology in the treatment process.

These actions will be reviewed during future site inspections and data reviews.
