4. Details of our assessment

This CAR form has been completed following an inspection by the Environment Agency under NRW registered permit KP3594VE.

This CAR form relates to an inspection carried out by an Environment Agency agricultural officer in response to reports of spreading at deployment D10039 under permit KP3594VE operated by Trade Effluent Services Limited. The deployment is located at Cross Lanes Farm, Tarvin, CH3 8HE.

The attending officer visited site on 12 February 2026 and observed spreading taking place on field TES 1.

- No amenity issues were noted during the inspection.
- The officer checked for signs of runoff from the spreading operation but did not observe any, noting the watercourse nearby was clear with no runoff entering.

The deployment states spreading will take place between February and May 2026 prior to seed bed preparation.

No non-compliances were noted during the inspection.
