

4. Details of our assessment

Self report of an oil spill from the British Airways maintenance hanger. The site holds discharge permits AN0225101 and AN0225102. For the sites surface run off and de-icer. The site has multiple oil interceptors, as well as a balancing pond prior to discharge to the Sefton brook, the site has another discharge location to the Tredogan brook to the north of the site.

Following the self report by BA a spill investigation was undertaken and issued, this contained the below information.

On 27th March 2026 a ground power unit was placed into a skip and collected by the appointed waste contractor. During collection and transport the skip leaked oil from the security lodge up to the waste area. Upon the security team being made aware, spill material was deployed and the incident was reported to NRW. The unit had been drained prior to being put into the skip, so an internal investigation is being carried out. The oil has been identified as Castrol Vecton15W-40 CK-4 and approx. 50l of oil was spilt. Upon further investigation this week, the oil is currently sat within the site's drainage chambers due to the lack of rain.

Spill absorbent granules and spill socks were used around the surface water drains in the road to prevent further entry. The oil that entered the drains would have been captured by the oil interceptors on site to the west and north prior to discharge to the Sefton and Tredogan brooks respectively.

A tanker attended site on the 7th of April to remove the oil from the interceptors and drains. A further root cause analysis is being conducted by BA to prevent recurrence.

The Sefton and Tredogan brooks were both inspected independently by NRW and BA, where both streams showed no impact of oil, indicating that the on site interceptors and drainage network contained the oil.
