4. Details of our assessment

The purpose of this Compliance Assessment Report is to record compliance with the

Look-Up Table (LuT) provisions set out in the environmental permit.

On 09 March 2026, you notified us of an OSM final effluent compliance sample taken at Betws Yn Rhos WWTW (CG0088601).

The LuT permit limit for Biochemical Oxygen Demand (BOD) is 20mg/l. The reported sample result was 24mg/l, representing an exceedance of the LuT value.

As this is the first exceedance recorded for this parameter at Betws Yn Rhos WWTW within the preceding twelve consecutive months, the exceedance is covered by the LuT provisions.
