3. The Discharge shall occur only when the sewage pumping station is inoperative as a result of one or more of the following:
- (a) electrical power failure not due to the act or default of the consent holder, its agents, representatives, officers, employees or servants;
 - (b) mechanical breakdown of duty and standby pumps;
 - (c) rising main failure;
 - (d) blockage of the downstream sewer not due to the act or default of the consent holder, its agents, representatives, officers, employees or servants;

and it is not reasonably practicable to dispose of the sewage otherwise. There shall be no undue delay on the part of the consent holder in remedying any such failure or breakdown.

Condition 3 (a) - Power was out for approx 4 hours. we wouldnt expecy DCWW to be able to get a generator onsite within this time frame. Whilst the site is compliant in regards to this incident, we would however like you to consider installation of a permanent generator on site to minimise polllution events affecting the watercourse
