4. Details of our assessment

Fenton Farm Poultry Unit visited on the 19 February 2026.

No laying birds were on site during inspection as business was in the process of cleaning and re-stocking.

On checking numbers of laying birds it was confirmed that numbers never exceed 64,000, as they are tightly monitored by Lion Quality Mark, farm assurance, that also monitor this aspect.

New Manure store has been approved by planning and is planned to be completed in 2026. Planning granted under 24/075/PA.

Manure is exported as allowed under Water Resources (Control of Agricultural Pollution) (Wales) Regulations 2021 (CoAPR), with all details confirmed under Nitrogen Management Plan. Until new store is erected manure kept in field heaps, confirmed by Nitrogen Management Plan risk maps provided.

Permit Condition 1.1.1(b): The operator shall manage and operate the activities using sufficient competent persons and resources. What training is provided to staff and do you keep a record of this?

Permit Condition 1.1.1 (a) The operator shall manage and operate the activities in accordance with a written management system that identifies and minimises risks of pollution, including those arising from operations, maintenance, accidents, incidents, non-conformances, closure and those drawn to the attention of the operator as a result of complaints.
