4. Details of our assessment

Myself and Kirsty Allwood attended on pre-planned OSM inspections and were met by the Area Supervisor, Senior Operative and two Process Scientists – thank you all for your time during the inspections. The weather was mild and cloudy following stormier weather the day before.

There was a DCWW operative on site when we arrived that appeared to be undertaking normal routine operations (de-sludging etc). The site is manned 3 days a week typically. We started at the head of works where all flows enter site via gravity to open chambers directing flow to the inlet screens. All screenings are macerated and stored in a wheely bin. Storm flows pass through a bar screen. A penstock is in place to restrict PFF accordingly. Flow monitoring was in place. Storm flows are diverted to a large below ground storage tank. When full flows are then passed through to the Humus tank and combined with FE for discharge. Flows are ferric dosed following screening before primary settlement and the site also has pH balancing so doses with Bicarbonate as needed in the distribution/siphon chamber before the filter beds. Despite the investment done on site to upgrade, the primary settlement tank was showing signs of ageing, but did not appear to be allowing any carryover. The siphon took some time to operate due to works on site, but worked as designed and the filter arms were rotating freely with no blockages. The filter arms are due to be replaced as part of the previously agreed scheme for the site. The Humus tank was also low, having been de-sludged, but with no signs of excessive solids or problems. The FE chamber had a clearly marked sample point that would flow over/through a v-notch weir but there was no flow at the time due to de-sludging. The FE chamber also has temp and pH sensors. The sludge holding tank appeared to be relatively full.
