4. Details of our assessment

This Compliance Assessment Report follows a review of routine quarterly emissions monitoring returns for Quarter 4 of 2025 plus the 2025 annual returns.

1. Emissions Monitoring Returns**a) Emissions to Air****Units 1- 4**

Emission points A1 - A4. All emissions were compliant with the permitted ELVs throughout the period.

During 2025, emissions were compliant with their respective annual ELVs.

b) Emissions to Water

Emission points W1, W2 & W3 - all parameters within permitted limits.

2. Annual Returns

- Annual Reporting Forms for 2025 were supplied as required, including AR1 & HR1.
- 2025 CEMs invalidation logs recorded zero invalid hours and days for all units.
- 2025 End of Year Review received, 100% ELV compliance achieved during 2025, no notifiable (Schedule 5) incidents reported.

The annual report states that *'Uniper continues to progress plans to construct a new Low Carbon Power Development at the Connah's Quay Site to ensure the continued generation of energy at the site. A full planning permission / Development Consent order application has been made and a full Environmental Permit application will soon follow in early 2026. A formal decision has been made by Uniper UK Ltd to extend the operational life of the existing Connah's Quay CCGT Power Station (CQ-B) to the year 2039 (on a reduced number of units).'*

At the time of writing this report, it can be confirmed that NRW has received applications for a new bespoke Environmental Permit for the proposed power station development and also for changes (variation) to the existing site permit. Duly making checks and subsequent determination by NRW's permitting service will now commence.
