4. Details of our assessment

On 19th March 2026 Angharad Clark attended site and met with the Owner.

The Site

The site is a restoration project where historical quarrying had damaged the environment. The Operator is continuing to remediate the damage by infilling the voids with inert material.

The site was in good condition with imported inert waste spread evenly over reclamation area. A lot of work has been completed but there is still two to three years of work to achieve.

Permitted activities

The Operator currently only accepts waste from the Local Authority. The volumes of waste vary depending on what projects are being carried out by the Local Authority at the time. Visual inspection showed that the imported waste is of good, inert quality and is well within the codes specified in the permit.
