4. Details of our assessment

On 19th March 2026 Angharad Clark attended site and met with the Environment Manager and the Head of Pembrokeshire Waste Collection. This inspection follows the NIA assessment report sent previously.

The Site

The site was in excellent condition with good waste segregation and permitted volumes complied with.

Noise

No noise nuisance was observed outside of the site boundary at the time of the inspection by the inspecting officer.

General Management

The site was running smoothly. I arrived at one of the busiest times of the day and there was no evidence of waste build-up or mixing.

Operating Techniques

The Environment Manager stated that they were in the process of applying to change the operating technique for glass deposit. At present, the doors to the glass shed must be closed before the lorry drops its load in order to minimise noise. This slows down operations considerably and so the operating technique will be changed to allow the deposit of glass with the shed doors open. The Environment Manager will send information to NRW showing that noise nuisance is not caused by this change in operation in due course.
