4. Details of our assessment

Compliance assessment form relating to incident reported to Natural Resources Wales by Dwr Cymru on 14th July 2025.

Incident details

Premature spill from the storm tank at Laugharne WWTW. Site was passing forward 2l/s, FPF is 11l/s.

This was caused by the inlet control valve having a restriction and not allowing full flow through the process.

The spill started at approx. 15:00PM and lasted until the issue was resolved at 18:16PM.

Unable to get outfall samples due to the outfall being in the middle of the estuary.

Permit Breach

Condition 2.3.2 (a) states that the discharge specified in table S3.3 (Settled Storm Sewage) shall only occur when and only for as long as the flow passed forward is equal to or greater than the overflow setting indicated due to rainfall and/or snow melt.

This discharge occurred outside of the above conditions.
