4. Details of our assessment

Myself and Kirsty Allwood attended on pre-planned OSM inspections and were met by the Area Supervisor, Senior Operative and two Process Scientists – thank you all for your time during the inspections. The weather was mild and cloudy following stormier weather the day before.

We started at the head of the works, which was pumped flow from the Pumping Station in Three Cocks. The Primary Settlement tank had a layer of scum that didn't appear to be settling properly and the tank was showing signs of aging. The top of the tank had scum lines suggesting at some point it has filled and potentially overflowed. Flows then passed through the defunct High Flow Filter before being pumped up to the old primary settlement tank, then passing onto the filter beds. The arms were rotating freely and distribution appeared even during the inspection. The render was starting to fail on the outside of the filterbed but no leaks or impact to treatment was observed. Flows then passed to the Humus tank which has some solids floating but they did not appear to be leaving the site. The Final Effluent was clear. We did not inspect the outfall.

The site is showing signs of age/wear and should be considered for renewal. The defunct high-flow filter has been non-operational for some time, updates to the site could remove this and then the need for the pumps from this filter to the filter bed.
