We have not received the required abstraction return(s) for licence number 23/64/16/0007 for the period 2019, 2020, 2021, 2022, 2023, and 2024. This is a breach of your licence conditions and is an offence under section 24(4)(b) of the Water Resources Act 1991.

Please ensure the outstanding returns is submitted by 10/07/2026.
