4. Details of our assessment

During a routine compliance assessment check that we have carried out on 27 March 2026, it was noted that the EDM operational time for this asset was less than the minimum of 90%.

The operational time provided in the 2025 EDM Annual return for AN0099301, Tank Near Pit CSO Ynysybwl, was 89.65 %.

This is a contravention of the Permit.

Condition 3.1.1 states that;

“The operator shall, unless otherwise agreed in writing by Natural Resources Wales, undertake the monitoring specified in the following tables in schedule 3 to this permit:

(a) point source emissions specified in table S3.1 and table S3.4”

This contravention of the permit is classed as a Category 4 breach.

Category 4: when the EDM is operational for 60.01-89.99% of the calendar year. It's reasonably foreseeable that that there will be no environmental impact as the % indicates that the overflow is receiving reasonable monitoring and that the operator is likely to have reacted to any operational issues in a timely manner.
