4. Details of our assessment

During a routine compliance assessment check that we have carried out on 02/04/2026 it was noted that the EDM operational time for this asset was less than the minimum of 90%.

The operational time provided in the 2025 EDM Annual return for S/01/07909/O CSO at Pen-Y-Bont-Fawr Wastewater Treatment Works was 83.09%

Condition 3.1.1 states that The operator shall, unless otherwise agreed in writing by Natural Resources Wales, undertake the monitoring specified in the following tables in schedule 3

Guidance for scoring the non-operational time suggests that this may have had a CCS category 4 impact - when the EDM is operational for 60.01-89.99% of the calendar year. It's reasonably foreseeable that there will be no environmental impact as the % indicates that the overflow is receiving reasonable monitoring and that the operator is likely to have reacted to any operational issues in a timely manner

You have confirmed that the root cause was signal issues and it was resolved in November 2025. Therefore I have marked the actions on this CAR as complete.
