4. Details of our assessment

4 Recycling – EPR/AB3693FT

Waste Regulation Officer Daniel Hopkin attended the permitted facility of Rosedew Farm run by 4Recycling Ltd at Rosedew Farm, Llantwit major, Vale of Glamorgan, CF61 1PZ on the 16th of April 2026. 4 Recycling hold a SR2010 No17 permit for this site. This was a routine site inspection. On arrival I was met by the onsite contact Matthew Conolly who showed me around the site and answered my questions. The weather was dry with little wind during the visit. I arrived at 10:00.

Site Documentation

All documentation for the site was stored in a secure container, this site does not have an office on the premises but all paperwork was stored appropriately, the sites permit, Environmental Management System (EMS) and a site diary detailing all site movements and lagoon inspections were present, compliant with permit condition 4.1.2.

Site Infrastructure

All site infrastructure was being appropriately maintained, there were no signs of damage to the lagoon and the site diary contained information on lagoon inspections taking place regularly.

There was only one waste type being stored within the permitted area in the lagoon.

Waste Returns

Following the visit, a desk review of the sites waste returns was completed. All required

waste returns have been submitted to NRW. Compliant with permit condition 4.2.2.
