## 4. Details of our assessment

**This CAR form has been completed following an inspection by the Environment Agency under NRW registered permit KP3594VE.**

This CAR form relates to an inspection carried out on 10 April 2026 at deployment D10053 under permit KP3594VE operated by Trade Effluent Services Limited. The deployment is located at Pool Farm, Tarporley, CW6 9SD. The weather at the time of the inspection was dry and sunny.

Spreading had taken place over the previous 2 days and was due to take place the same afternoon. The following wastes had been or were due to be spread:

- ABP Shrewsbury – 02 02 04
- Croda Widnes – 02 03 05
- Maelor Foods – 02 02 04
- Nimbus Foods – 02 06 01

The wastes had been applied via sub-soil injection. A visual inspection of field 'E8' took place where wastes had been spread. A slight odour was observed; however, this was localised to the field and was not detectable off-site. There was no mud/litter on the road approaching the fields. Buffer zones of 10m next to the watercourse which borders the west of the field appeared to have been adhered to. No pooling of waste was observed, and the ground conditions appeared to be in a suitable condition.

The nurse tanks were situated in the agreed location, and each tank had lockable valves.

No non-compliances were noted during the inspection.
