### NRW Light-Touch Review Considerations

#### Is the risk assessment site-specific?

Yes. The Climate Change Risk Assessment is specific to the permitted installation and its location, with consideration given to site setting, topography and surrounding land use. Identified risks and controls are clearly linked to on-site activities and infrastructure.

#### Have climate hazards and risks relevant to the sector been considered?

Yes. The assessment considers climate hazards relevant to the ceramic manufacturing sector, including increased rainfall, storm events, power disruption, higher temperatures and drought conditions, and the potential effects these may have on operations, utilities and site management.

#### Have short, medium and long-term climate risks been included?

Yes. The assessment considers potential climate impacts over short, medium and long-term timescales, including projected temperature increases and changing weather patterns over future decades.

#### Are current and future climate projections or scenarios referenced?

Yes. The operator references future climate projections, including anticipated temperature increases and increased frequency of severe weather events, to inform risk identification and management considerations.

#### Does it describe what elements are exposed (at risk)?

Yes. The assessment identifies exposed elements including buildings, plant, utilities, raw materials, workforce welfare and aspects of the supply chain. These are discussed in the context of identified climate hazards and their potential operational impacts.

#### Does it propose actions to manage the higher risks, and are these realistic?

Yes. Proportionate and realistic control and adaptation measures are outlined, including maintenance arrangements, contingency planning for weather-related disruption, protection of materials and chemicals, provision of alternative utilities, and management oversight. Measures are appropriate to the nature and scale of the installation.

#### Does it include key performance indicators (KPIs)?

While formal numerical KPIs are not explicitly listed, the assessment embeds climate risk management within existing management and maintenance systems, workforce monitoring and periodic management review, which is proportionate at this stage for a light-touch review.

**Is there a plan to regularly review and update the assessment?**

Yes. The operator states that the Climate Change Risk Assessment will be reviewed periodically by management, including consideration of updated scientific projections and following significant climate-related events or operational changes, supporting continual improvement.
