### 4. Details of our assessment

DCWW self reported a spill to the environment from the settled storm overflow tank at

Clawddnewydd WwTW on 19th February 2026. This was caused by an unforeseen Scottish Power outage.

DCWW submitted a 3rd party claim and storyboard, detailing their investigation findings and actions that were undertaken to rectify the issue.

The Scottish Power outage impacted the site at approximately 18:10 on the 19<sup>th</sup> February. Tankers were utilised while SPEN worked to restore power to the site. Telemetry data shows well level during the time of the spill. Spill duration was approximately 18:10 – 21:27 and FPF was at zero between 18:20 – 21:15.

The site had been experiencing storm conditions prior due to heavy rainfall in the area, therefore, any discharge is believed to be diluted. Watercourse samples were unobtainable due to H&S reasons, however, a storm tank discharge sample was obtained with a low ammonia reading of 3.82mg/l (photos provided).

NRW accepts the 3rd party claim.
