#### **4. Details of our assessment**

On the 14 April 2026 a routine sample was collected by Natural Resources Wales from the sample point of the Sewage treatment plant serving Dolguog Cabin Park and revealed an exceedance in the following discharge parameters.

*Non-Compliances (recorded in summary) Actions to be addressed –*

**Biological Oxygen demand (BOD)**

Permit limit 20mg/l

Sample result 42.1 mg/l

**Suspended solids (measured after drying at 105° C)**

Permit limit 30mg/l

Sample result 76 mg/l

These result represents a minor breach and has been assessed as a Category 3 environmental impact (Minor).

Please ensure the sewage treatment plant serving Dolguog Cabin Park is brought back into regulatory compliance and provide any evidence of works carried out to action this to NRW by the 15 May 2026.
