4. Details of our assessment

This report details the site visit made on the 23 April 2026 to United Recycled Aggregates Ltd at Birdport Docks Site, reference number EPR/PB3230AQ Natural Resources Wales (NRW) Officer Carla CURTIS and Anna ANDREWS attended the site at Corporation Road, Newport, NP19 4RE at 11.30 where we met with the Plant and Transport Director.

GENERAL OBSERVATIONS

United Recycled Aggregates Ltd is seeking a permit surrender for the whole site, under permit EPR-PB3230AQ. The purpose of the visit was to complete a final site inspection to facilitate the determination of the surrender application. At the time of the inspection, all operations on site had ceased, all waste(s), and machinery had been removed, there was a bit of litter that had just blown in since the site has closed, the Plant and Transport Director said he was going to arrange for the litter to be removed.

Based on the visual inspection of this site, NRW Officers feel that the risk to the environment is sufficiently low and would recommend that no intrusive site inspection is required.

To confirm, based upon the type of permit held by United Recycled Aggregates Ltd – (Permit Number - EPR-PB3230AQ) and operations previously undertaken on site, it is my recommendation that this permit would be eligible for a low-risk surrender.
