### 4. Details of our assessment

NRW officers carried out a site inspection at Graigfechan sewage treatment works on the 14th April 2026.

A representative from DCWW was on site.

There are no sewer overflows in the catchment and no storm storage or overflow on site. Maximum flow is 0.7 l/s and the population served is approximately 170 people.

An operator attends site twice a week to carry out routine checks and maintenance.

The inlet is gravity fed and flows pass through a macerator to break down the rags. The sewage flows into primary settlement tanks and any settled solids are desludged into the sludge tank. The sludge is dewatered and the water is returned to the primary tanks. The sludge is then removed from site by tankers and taken to sludge processing treatment works.

Flows are then passed through a high rate filter to help remove finer solids, before going through further treatment in the biofilters. There are 2 on site. Both arms were moving freely and there was even wetting of the filter bed. There was some moss growth on the filter media - *it is advised that this should be removed.*

The effluent is then settled again in the final (humus) tank. This was clear of scum and the effluent leaving the tank during the visit was clear.

This final effluent is then passed via a sampling chamber - which was correctly labelled and accessible.

This is then discharged via an outfall to the watercourse (Dwr Ial) as final effluent. The outfall was inspected and the water was clear and free from sewage fungus or debris.

No issues were found on site.

There is no telemetry on site and therefore a follow up data audit is not possible at this time.
