4. Details of our assessment

On the 10th April 2026, DCWW self reported to NRW of a potential blockage at Pwllglas WWTW resulting in flows diverting to storm and causing a spill to the environment.

Following the self report, DCWW produced a storyboard, detailing the investigation into the root cause and steps taken to resolve/prevent future occurrence.

The investigation into root cause has been determined as a PLC failure. As a result, the site actuator lost control, which lead to a blockage between the inlet and the aeration basin causing flows to back up and divert to storm. DCWW staff attended site and cleared the blockage and reprogrammed the PLC fault, stopping the spill. Telemetry showed the spill duration as 07:43 – 09:22.

Samples were taken of the upstream, outfall and downstream once the storm spill had ceased.

The results were:

Upstream ammonia 0.01mg/l & Turbidity 4.33FTU

Point of Entry ammonia 1.27mg/l & turbidity 5.24FTU

Downstream ammonia 0.10mg/l & turbidity 4.72FTU

The storm outfall at site is also the same location for the inlet CSO and the treated final effluent.

On investigation, DCWW also found there to be an issue with the spill channel as it did not record a spill and therefore the level 6 spill channel alarm was not generated. DCWW are currently looking into resolving this as soon as possible.
