## 4. Details of our assessment

This Compliance Assessment Report (CAR) form has been produced to assess the Quarter 1 Returns for the period January - March 2026. The permit requires quarterly reporting of the emissions to water at Emission point W1.

### **IR4B - Reporting**

Records have been submitted to Natural Resources Wales (NRW) in accordance with permit condition 4.2.3, within the specified time period. The returns have been submitted using the correct Reporting form.

### **IR3A(1) Emissions to Water**

CAR form CAR\_NRW0050534 dated 20th February 2026 confirmed that the pre-operational phase of Phase 2 Operations had been satisfied and that Phase 2 could begin immediately, and thus the point source emissions limits to water set out in table S3.1 are considered to have changed from Phase 1 Operations to Phase 2 Operations on the same date. This has resulted in some of the limits being increased, and others being tightened.

All parameters submitted appear to be in compliance with the Phase 2 limits.

The quarterly reporting for emission limits W2 and W3 do not indicate any issues, and demonstrate compliance with the permit in this monitoring requirement.
