3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

You are non-compliant with your permit.

We are currently considering taking enforcement action against you for the non-compliance recorded above. We will contact you in due course.

4. Details of our assessment

Routine monitoring samples were taken on 14th April 2026 by NRW. The analysis found that the biological oxygen demand (BOD) concentration was 36.7 mg/l which exceeds the permit maximum limit of 20 mg/l.

The BOD result is classified as a category 3 failure which has the potential to have a minor environmental impact.

The analysis also reported Ammonia levels at 30.3 mg/L significantly above the criteria value of 2 mg/L. This has resulted in a C1 failure with the potential to cause major environmental impact.

The analysis also showed suspended solids exceedance at 78 mg/L above the criteria value of 30 mg/L. This has resulted in a second C1 failure with the potential to cause major environmental impact.

NRW are considering enforcement actions.
