4. Details of our assessment

This Compliance Assessment Report follows a review of surface water and air emissions monitoring data, along with annual reporting for the period January - December 2023.

Emissions monitoring data is reported annually and was received 30/01/24 as required by the permit.

The plant permanently ceased processing gas on 30/06/23.

Emissions to Surface Water (W1)

Monitoring was completed in accordance with the permit and emissions were compliant with their respective emission limit values (ELVs).

Surface water monitoring and reporting must continue until permit surrender (unless otherwise agreed in writing with NRW).

Emissions to Air (A1, A2, A3 & A4) January - June

Monitoring was completed in accordance with the permit.

CO and NO_x emissions were compliant with their respective ELVs.

A number of SO₂ ELV exceedances at emission point A1 (Thermal Oxidiser) occurred on 21/05/23 and were previously subject to compliance assessment and scoring. Refer Compliance Assessment Report reference CAR_NRW0041621.

Further SO₂ ELV exceedances at emission point A1 were reported via a Part A notification received on 02/07/23 followed by a Part B on 13/07/23.

It was reported that on the 01/07/23, and due to a planned plant shutdown, the permitted hourly SO₂ ELV of 190mg/Nm³ was breached at 14:50 and continued to breach until 16:50 05/07/23, with a maximum hourly average concentration of 981.8mg/Nm³.

These SO₂ breaches have been consolidated as a minor non-compliance (C3) against

permit condition 3.1.2.

The thermal oxidiser will be permanently decommissioned as part of site closure and permit surrender. No further action required.

Annual Reporting

The annual report was received 30/01/24. This contained monitoring results and performance parameters as required by the Permit. Monitoring conducted for this period shows compliance with the permitted ELVs apart from excursions for SO₂ at emission point A1 notified by the operator and detailed above.
