## 4. Details of our assessment

### Overview

This Compliance Assessment Report (CAR) has been prepared following an inspection of the permitted site GP3337KD.

The permitted activities of EPR/GP3337KD have ceased and are now being undertaken at the operator's other site under EPR/EP3230BW. The Operator has stated that the site has been non-operational for seven years.

### Site

It was noted that approximately 50 bags ~ 50 tonne of sodium sulphate were being stored at the site. The operator stated this was a temporary storage and the bags were due to be moved the next week.



Officers briefly entered the main warehouse building. However, the presence of open roof sections and large deposits of dust presented an unacceptable safety risk, and further access was not pursued.



**Permit Surrender**

The operator has stated their intention to surrender the existing environmental permit for the installation.

The operator is reminded that an installation permit remains in force until formally surrendered and accepted by Natural Resources Wales.

To surrender the permit, the operator must:

Cease all permitted activities permanently and confirm there is no intention to resume operations.

Remove all installation-related materials and infrastructure, including fuels, chemicals,

wastes, tanks and plant that could pose a pollution risk.

Assess the condition of the site and compare it against the baseline Site Condition Report (SCR) submitted at permit issue.

Prepare and submit a surrender SCR demonstrating that there has been no deterioration of land or groundwater, or that any deterioration has been suitably remediated.

Submit a permit surrender application to Natural Resources Wales together with all supporting evidence and any relevant application fee.

Provide any additional information requested by Natural Resources Wales during determination.

The permit will remain in force, and the operator will remain legally responsible for compliance with all permit conditions, until written confirmation of surrender is issued by Natural Resources Wales.

### Legal status of this report
