4. Details of our assessment

Overview

This Compliance Assessment Report (CAR) has been prepared following an inspection of the permitted site BV5386IX.

GS Yuasa Battery Manufacturing UK Limited (Yuasa) at Rassau Battery Manufacturing Site in Ebbw Vale manufactures valve regulated, sealed, lead acid batteries. The main raw materials used are lead and sulphuric acid. The site also manufactures lead oxide by the Shimadzu process, an essential ingredient in the production of batteries.

The purpose of the inspection was to:

- Meet with the operator to discuss permit requirements.
- Introduce the designated lead regulatory officer.

Records

Condition 1.1.1 of the environmental permit requires the operator to:

(a) Manage and operate activities in accordance with a written management system that identifies and minimises pollution risks, including those arising from operations, maintenance, accidents, incidents, non-conformances, and complaints.

(b) Ensure sufficient competent personnel and resources are in place.

Condition 1.1.2 requires records demonstrating compliance with Condition 1.1.1 to be maintained.

Pre-application advice – permit variation

The operator advised that the flow rate on some abstraction points has changed so needs updating on the permit. Where changes are proposed to activities permitted under the EPR Permit, Natural Resources Wales (NRW) encourages the use of its **pre-application advice service** prior to submitting a permit variation application.

- whether a permit variation is required;
