4. Details of our assessment

The purpose of this visit was to hand regulation of the site from the current NRW Inspector Brigid Armstead to Richard Taylor who will be the main site contact going forward. This meeting and inspection served as an introduction to the site and an overview of site operations, management and site layout. This physical inspection was limited to a familiarisation exercise and did not look in detail at the technical processes, goods and waste movements, physical infrastructure or drainage systems at this time. The site representative held an in date CIWM Continuing Competence Certificate to show technical competence.

The site was observed to be operating within the permitted site boundary, and the site was clean and tidy with waste streams well catered for. There was no excessive noise or odour from the site and no evidence of vermin or invasive species observed. A few roof vents were producing negligible emissions of vapour, and there is no process emission to surface water or sewer from this site.

The process was walked through with the site representatives with the relevant PE worn, with areas were accessible including waste reception, product despatch, individual product holding tanks, and the on-site laboratory used for checking specifications. Staff were available for questioning and proved to be knowledgeable of the site processes. Records are held electronically here with a paper log back up. A disused paint bay was also seen which is in the stage of being dismantled. A query to the Q1 waste returns on why the waste leaving site was answered because of the additional waste streams generated from these improvement works.

Site reported that business was carrying on as usual. The internal and external areas of the site were inspected and found to be well organised. No issues seen whilst on site.
