4. Details of our assessment

Natural Resources Wales Senior Industry Regulation Officer Ricky Hartleb and Lead Specialist Officer Rebecca Harwood visited Tradebe Healthcare National Limited, Wrexham Clinical Waste Treatment Facility (Incinerator), Marlborough Road, Wrexham Industrial Estate, Wrexham, Clwyd, LL13 9RJ at 12:33pm on Friday 27 February 2026, as part of an arranged site familiarisation / compliance visit.

The visit was accompanied by the SHEQ Officer, Site Operations Manager and Plant Manager.

At the time of the visit the site was operational and the weather was dry and sunny.

IR1A General Management

A management briefing was provided covering site operations, staffing structure, and ongoing work to increase onsite technical resilience.

No compliance concerns were identified.

IR2A Permitted Activities

The installation was operating within its permitted activities (Schedule 1, Table S1.1). Waste storage areas were clean and well organised. Waste streams were stored in the correct designated areas, in line with the permit and the site's waste acceptance/handling procedures (Conditions 2.3.2–2.3.7).

Two minor compliance issues were observed:

One incorrectly labelled waste bin was found in the quarantine area. This was immediately removed once highlighted.

There was residue ash on the ground within the IBA (bottom ash) skip area at the time of the inspection. Staff stated that this would be rectified following the visit. Officers will review this on further inspections.

IR3A(2) Emissions to Air

Dioxins sampling was undertaken on 19/02/2026, with the full report submitted to NRW on 02/03/2026.

Results indicated no exceedances of emission limits. The operator has now returned to the standard 6-monthly monitoring frequency for emission point A1, in line with the permit.

The CEMS display was reviewed in the control room. No exceedances were observed at the time.

Improvement Condition 16

A response to IC16 was received on 30/01/2026. This is currently being reviewed by NRW.

The operator discussed their intention to submit a permit variation application in March 2026. This relates to ongoing development work and proposed changes at the installation.
