4. Details of our assessment

PERMIT INSPECTION

On Tuesday 28th April 2026 NRW Officers Cerys PHILLIPS, Carla CURTIS, and Leah GOLDING attended the facility at 11:30 am for an announced routine inspection of permit number EPR-CB3398HW. The weather was dry and cloudy at the time of inspection.

Upon arrival at the site, NRW officers met with Director/Owner, Terry ROWE who gave a brief introduction regarding the site processes.

The site was not operational at the time of the inspection and has not been since the issuing of the permit on 07/02/22. Work with Dwr Cymru Welsh Water outlined in the previous CAR form CAR_NRW0041936 regarding the re-routing of water pipework has since been completed, and a concrete impermeable surface has been installed.

Separate bays for waste storage have been constructed and are clearly labelled, with skips in place for waste streams. Additional changes have been made across the site to allow for operations including CCTV and office space.

There was no excessive noise and with no excessive airborne dust present during the site inspection. There were also no offensive odours witnessed by NRW Officers on site and security was of no concern.

Mr ROWE advised that, now that all works have been completed, the site is ready to begin operations.
