4. Details of our assessment

On Thursday the 23th April 2026 Natural Resources Wales attended site.

This was due to a report received relating to dust and plastic blowing from the permitted site. The visit was carried out by Waste Regulation Officer Ian Thomas, accompanied by Waste Regulation Officer Amy Henderson.

On arrival at site, officers were met by Steffan and Craig, site operatives of New Horizon Plastics and Animal Bedding.

The site was checked for evidence of plastic or dust being blown, having walked around all areas of the permitted area, no evidence was apparent to justify the report.

Whilst we looked around **Unit 9**, it was noted that the ZX Separation technology machine was in place on the yard, it looked to be in use as IBC containers were sited next to it to collecting liquid and waste materials. The machine was previously noted on CARS forms. The permit references Schedule 1 – Operations, Table S1.1 activities.

Permitted activities in the external areas of Unit 9 are limited to waste acceptance storage and shredding.

The machine was removed on guidance relating to the information on the permit, however it looks to be back in use which is not in accordance with the permit conditions.

Scored C3: Previously scored against permit condition. Non permitted activities have not been assessed for risk.

Further to this, relating to Unit 9, the acoustic report states “Roller shutters and personnel doors must always be kept closed when not in use for immediate, momentary vehicle/personnel ingress/egress”

At the time of our visit the roller doors all looked to be fully open.

Action: Please ensure roller shutter doors are closed fully unless used for ingress/egress.
