### 4. Details of our assessment

The non-compliance listed above was identified during our annual 2025 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self-Monitoring (OSM) conditions.

Please note: this CAR is dated 31/12/2025 as these non-compliances relate to annual 2025 data, however for clarity I carried out the compliance assessment on 14/05/2025.

**Issue identified:**

Incorrect information was recorded in the Annual Summary Report (ASR) regarding a change to sampling frequency.

The frequency change end date is correctly recorded as 28/02/2025; however, an incorrect date of 01/01/2025 is included within the reason for change.
