4. Details of our assessment

This Compliance Assessment Report (CAR) follows the review of Q1 monitoring returns 2026 (January-March) for emission points W1, W2 and S1. This data was received by NRW on 27/04/26, which is within the timescales required by Permit Condition 4.2.3.

Point source emissions to water (other than sewer) Chemical Oxygen Demand (COD)

Both monitoring points (W1 & W2) recorded values within the permitted Emission Limit Value (ELV) (70mg/l) for COD during Q1. Monitoring points W1 & W2 recorded maximum values of 68mg/l & 41mg/l, respectively during Q1.

Biological Oxygen Demand (BOD)

Both monitoring points (W1 & W2) recorded values within the permitted ELV (30mg/l) for BOD during Q1. Monitoring points W1 & W2 recorded maximum values of 9.8mg/l and 4.11mg/l, respectively during Q1.

Suspended solids (SS)

Both monitoring points (W1 & W2) recorded values within the permitted ELV (50mg/l) for SS during Q1. Monitoring points W1 & W2 recorded maximum values of 39mg/l and 37mg/l, respectively during Q1.

Emissions to sewer

Emission point S1 recorded the following maximum values:

COD- 2042mg/l.

SS- 478 mg/l.

Flow (m³/day)- 1023 m³/day.

There are no permitted ELVs associated with emission point S1.
